**ORDER:-**

The Director of Handlooms & Textiles and Apparel Export Parks, Telangana State, Hyderabad, in the reference 3<sup>rd</sup> read above, has requested the Government to issue BRO and Administrative Sanction order for an amount of Rs.869.54 lakhs for 3<sup>rd</sup> quarter budget under State Plan and the aforesaid amount shall be debited to the Head of Account "2851-103-10-38-310-312:Financial Assistance to Handloom and Textile Promotion" from the BE Provision 2015-16 , duly authorizing the Director of Handlooms & Textiles and Apparel Export Parks, Telangana State, Hyderabad, Telangana State, Hyderabad to draw and disburse the amount.

In the reference 4<sup>th</sup> read above, the Government in Finance (EBS.VII) Department have issued a Budget Release order for an amount of Rs.8,69,54,000/- from 2015-16 towards meeting the expenditure for Power Tariff Concession Scheme to power loom unit holders in the Telangana State under the Head of Account "2851-103-10-38-310-312 towards Financial Assistance to Handloom and Textile Promotion" from the Budget Estimates Provision 2015-16.

Government, after careful examination of the proposals of Director of Handlooms & Textiles and Apparel Export Parks, Telangana State, Hyderabad and in pursuance of the Budget Release Order issued by the Finance (EBS-VII) Dept, in the reference 4<sup>th</sup> read above, hereby accord administrative sanction for an amount of Rs. 8,69,54,000/- (Rupees Eight Crores Sixty Nine Lakhs and Fifty Four Thousands only) towards meeting the expenditure for Power Tariff Concession Scheme to power loom unit holders in the Telangana State under Plan from the Budget Provision 2015-16.
