**ORDER:-**

In the reference 2<sup>nd</sup> read above, Government have accorded administrative sanction for an amount of Rs.1,80,840/- under Plan from the Budget Estimates Provision 2015-16 towards 8% State Government matching share under "Cooperative Handloom Weavers Thrift Fund Scheme" from the authorized amount of Rs.49,87,000/- for the 1<sup>st</sup> quarter of B.E.2015-16, after leaving a balance of Rs.48,06,160/-. Further in the reference 3<sup>rd</sup> read above, Government have authorized an amount of Rs.49,87,000/- for the 2<sup>nd</sup> quarter of B.E.2015-16, towards 8% State Government matching share under Cooperative Handloom Weavers Thrift Fund".Hence, an amount of Rs.97,93,160/- (Rs.48,06,160/- + Rs.49,87,000/-) is available under the "SH-63 Co-operative Handloom Weavers Thrift fund Scheme" towards 8% State Government matching share.

2. In the reference 4<sup>th</sup> read above, the Director of Handlooms & Textiles and Apparel Export Parks, Telangana State, Hyderabad, has stated that the proposals for Rs.48,26,118/- have been received from the Regional Deputy Directors (H&T), Warangal and Hyderabad towards 8% state matching share under the above scheme as detailed hereunder.

The Director of Handlooms & Textiles and Apparel Export Parks, Telangana State, Hyderabad has therefore, requested the Government to issue necessary administrative sanction and release an amount of Rs.48,26,118/- (Rupees Forty eight lakhs twenty six thousands one hundred and eighteen Only),towards 8% State Government matching share under "Cooperative Handloom Weavers Thrift Fund Scheme" from the allocated amount in the B.E. Provision 2015-16 and also requested to authorize her to draw the amount and release to the concerned societies.

Government, after careful examination of the proposal of Director of Handlooms & Textiles and Apparel Export Parks, Telangana State, Hyderabad and in pursuance of the Budget Release Orders issued by the Finance (EBS.VII) Department in the reference 1<sup>st</sup> & 3<sup>rd</sup> read above, hereby accord administrative sanction for an amount of Rs.48,26,118/- (Rupees Forty eight lakhs twenty six thousands one hundred and eighteen Only) under Plan from the Budget Estimates Provision 2015-16 towards 8% State Government matching share under "Cooperative Handloom Weavers Thrift Fund Scheme" from the available amount of Rs.97,93,160/- under the "SH-63 Co-operative Handloom Weavers Thrift fund Scheme" towards 8% State Government matching share.

5. The expenditure sanctioned in para (4) above, shall be debited to the following Head of Account.
