ORDER:-

In the reference 1st read above, Government have issued Common Budget Release Order for an amount of Rs.13,30,79,000/- to Handloom & Textiles, under Plan from the Budget Provision 2015-16 towards meeting the expenditure for the months of July, August and September, 2015 duly including an amount of Rs.1,12,50,000/- under the Head "2851-00-103-11-64-310-312"-Subsidy on purchase of Raw materials and directed the concerned Department to take necessary action for issue of Administrative Sanctions.

2. The Director of Handlooms & Textiles and Apparel Export Parks, Telangana State, Hyderabad in the reference 2nd read above, has submitted the proposals in respect of the pending claims for an amount of Rs.112.50 lakhs for the quarters ended 31.03.2013 and 30.06.2013 in the State of Telangana, as against to the budget provision of Rs.450.00 lakhs, for accord of administrative sanction and requested the Government to release an amount of Rs.112.50 lakhs to reimburse the subsidy on purchase of raw-materials i.e. Hank yarn and Dyes and Chemicals by the Primary Weavers Coop. Societies in the State of Telangana, under the Head of Account "2851-00-103-11-64-310-312"- Subsidy on purchase of Raw materials and also requested to authorize her to draw and disburse the said amount of Rs.112.50 lakhs to the concerned Assistant Directors (H&T) for onward reimbursement to the Primary Weavers Coop Societies of the new State of Telangana under the Scheme.

3. Government, after careful examination of the proposals of Director of Handlooms & Textiles and Apparel Export Parks, Telangana State, Hyderabad and in pursuance of the Budget Release Order issued by the Finance (EBS-VII) Dept, in the reference 1st read above, hereby accord administrative sanction for an amount of Rs.1,12,50,000/- (Rupees One crore twelve lakhs and fifty thousand only) under Plan from the Budget Provision 2015-16 towards meeting the expenditure to reimburse the subsidy on purchase of raw-materials i.e., Hank yarn and Dyes and Chemicals by the Primary Weavers Co-Operative Societies in the State of Telangana, in respect of pending claims for the quarters ended 31.03.2013 and 30.06.2013 in the State of Telangana.

4. The expenditure sanctioned in para (3) above, shall be debited to the following Head of Account:
