**ORDER:-**

In the reference 2<sup>nd</sup> read above, Government have accorded administrative sanction for an amount of Rs.33,00,000/- from the allocated funds of Rs.50.00 lakhs, under Plan from the Budget Provision 2015-16 under the Head 2851-00-103-11-65-310-312 Scheme for Training and Infrastructural Support to Handloom Sector for the months of July, August and Septemeber,2015, towards meeting the expenditure to take up the construction of Common work shed /C.F.C. to the (2) Handloom Weavers Cooperative Societies in Huzurabad Constituency. Hence, an amount of Rs.17.00 lakhs is available for the 2<sup>nd</sup> quarter of Budget Provision 2015-16 under the Head 2851-00-103-11-65-310-312 Scheme for Training and Infrastructural Support to Handloom Sector.

2. The Director of Handlooms & Textiles and Apparel Export Parks, Telangana State, Hyderabad, vide reference 3<sup>rd</sup> read above, has requested the Government to consider proposals for construction of incomplete Common Facility Centre (CFC) Building at HWCS Ltd., Alair, and accord sanction of amount of Rs.5.00 lakhs in addition to Rs.4,57,40,000/- (Rupees Four Crores Fifty Seven Lakhs Forty Thousand only) to take up the construction of incomplete Common Facility Centre (CFC) Building at HWCS Ltd., Alair under the Head 2851-00-103-11-65-310-312 Scheme for Training and Infrastructural Support to Handloom Sector” and also authorize the Director of Handlooms & Textiles and Apparel Export Parks, Telangana State, Hyderabad to draw and disburse the amount to the concerned Societies.

Further, in the reference 4<sup>th</sup> read above, the Director of Handlooms & Textiles and Apparel Export Parks,Telangana State, Hyderabad has requested to accord administrative sanction for an amount of Rs.17.00 lakhs (Rupees Seventeen Lakhs only) in order to settle the pending proposal of Project HWCS Ltd., Siddipet, Medak District for Addl. Construction of Common workshed under Scheme for Training and Infrastructural Support to Handloom Sector under Plan from the budget provision 2015-16 under the Head 2851-00-103-11-65-310-312 Scheme for Training and Infrastructural Support to Handloom Sector.

Government, after careful examination of the proposals, hereby accord administrative sanction for an amount of **Rs.17,00,000/-** (Rupees Seventeen Lakhs Only) from the available funds for the 2<sup>nd</sup> quarter of Budget Provision 2015-16 under the Head 2851-00-103-11-65-310-312 Scheme for Training and Infrastructural Support to Handloom Sector for the months of July, August and Septemeber,2015, towards meeting the expenditure to take up the construction of Common work shed /C.F.C. to the following (2) Societies:-
