ORDER:-

In the reference 1st read above, Government have issued common Budget Release Order for an amount of Rs.13,30,79,000/- under Plan from the Budget Estimates Provision 2015-16 towards meeting the expenditure for the months of July, August and September, 2015 under different Schemes duly including Rs.0.12 lakhs under "2851-00-103-11-08-310-312" i.e., SSI Clusters under Project Package Scheme Handlooms Cluster Development Programme and directed the concerned Department to take necessary action for issue of Administrative Sanctions.

2. The Director of Handlooms & Textiles and Apparel Export Parks, Telangana State, Hyderabad, vide reference 2nd read above has stated that in the (10) Handloom Clusters which are being implemented through the Assistant Directors (H&T), Cluster Assistants have worked on contract basis for an amount of Rs.5000/- per month per assistant for a period of one year initially for implementation of the Handloom Clusters sanctioned under IHDS.

3. The Director of Handlooms & Textiles and Apparel Export Parks, Telangana State, Hyderabad has, therefore, requested the Government to release an amount of Rs.0.12 lakhs towards meeting the expenditure to be payable to the Cluster Assistants and payment of balance amount to cluster Assistants under "2851-00-103-11-08-310-312" for the year 2015-16 under plan and also requested to authorize her to draw the said amount of Rs.12,000/- (Rupees Twelve Thousand only) and to incur the expenditure towards payment of balance amount to Cluster Assistants already appointed on contract basis in the Handloom Clusters sanctioned under Integrated Handloom Development Scheme (IHDS).

4. Government, after careful examination of the proposals of Director of Handlooms & Textiles and Apparel Export Parks, Telangana State, Hyderabad and in pursuance of the Budget Release Order issued by the Finance (EBS-VII) Department in the reference 1st read above, hereby accord administrative sanction for an amount of Rs. 12,000/- (Rupees Twelve Thousand Only) under Plan from the Budget Provision 2015-16 towards meeting the expenditure to be payable to the Cluster Assistants and due payment of balance amount to cluster Assistants for the months of July, August and September, 2015.

The Director, Handlooms & Textiles and Apparel Export Parks, Telangana State, Hyderabad is authorized to draw the amount sanctioned in para (4) above and to incur the expenditure towards payment of balance amount to Cluster Assistants already appointed on contract basis in the Handloom Clusters sanctioned under Integrated Handloom Development Scheme (IHDS).

7. This order issues in pursuance of the Budget Release Order issued vide G.O.Rt.No.2896, dt.08.09.2015 of Finance (EBS-VII) Department.
