ORDER:

In the reference 1st read above, the Government have issued a Common Budget Release Order for an amount of Rs.13,30,79,000/- plan from the Budget Provision 2015-16 under various schemes towards Meeting the expenditure for three months i.e., from July, August and September, 2015 (2nd Quarter). Out of which, an amount of Rs.1,87,67,000/- has been authorized under S.H. (07) i.e., "Interest subsidy / Rebate / Pavalavaddi Scheme" for incurring the expenditure for (3) months i.e., July, August and September, 2015.

2. In the reference 2nd read above, the Director of Handlooms & Textiles and Apparel Export Parks, Telangana State, Hyderabad has stated that the Assistant Director, (H&T), Mahaboobnagar and the Regional Deputy Director (H&T), Hyderabad has recommended the Interest Subsidy claims of PWCS's, Mahaboobnagar District and APCO to the extent of Rs.1,33,73,459/-.

3. The Director of Handlooms & Textiles and Apparel Export Parks, Telangana State, Hyderabad, has therefore, requested the Government to issue an administrative sanction order for an amount of Rs.1,33,73,459/- from the allocated amount of Rs.1,87,67,000/- from the B.E. Provision 2015-16 towards meeting the expenditure for the months of July, August and September, 2015 towards settlement of pending claims of PWCS's, Mahaboobnagar District and APCO under Pavalavaddi Scheme under the relevant Head of account, and also authorize him to draw and disburse the amount to the concerned.

4. Government, after careful examination of the matter and in pursuance of the G.O. 1st read above, hereby accord Administrative sanction for Rs.1,33,73,459/- (Rupees One Crore thirty three Lakhs and Seventy three Thousands four hundred and fifty nine only) from the allocated amount of Rs.1,87,67,000/- from the B.E. Provision 2015-16 towards meeting the expenditure for the months of July, August and September, 2015 towards settlement of pending claims of PWCS's, Mahaboobnagar District and APCO under Pavalavaddi Scheme

5. The expenditure sanctioned in para (4) above, shall be debited to the following Head of Account:-

- "2851 - Village & Small Industries;
- M.H.(103) - Handloom Industries;
- GH 11 - Normal State Plan;
- SH (07) - Interest Subsidy/ Rebate Scheme;
- 310 - Grants-in-aid;
- 312 - Other Grants-in-aid".
