ORDER:-

In the reference 1st read above, Government have issued common Budget Release Order for an amount of Rs.10,04,29,000/- under plan from the Budget Estimates Provision 2014-15 towards meeting the expenditure for the months of June, July and August under different Schemes duly including Rs.60.77 lakhs under “2851-00-103-11-11-310-312” i.e., Financial Assistance to Weavers and directed the concerned Department to take necessary action for issue of Administrative Sanctions.

2. The Director, Handlooms & Textiles and Apparel Export Parks, Telangana State, Hyderabad, vide reference 2nd read above has stated that an amount of Rs.87.85 lakhs has been proposed in the Budget Estimates for the year 2014-15 towards balance revenue deficit expenditure payable to National Institute of Fashion Technology (NIFT), Hyderabad. Therefore, he requested the Govt., to sanction and release an amount of Rs.87.85 lakhs under “2851-00-103-11-11-310-312” i.e., Financial Assistance to Weavers, from the Budget Estimates provision 2014-15 towards balance revenue deficit expenditure payable to NIFT, Hyderabad.

3. Government after careful examination of the proposals of Director of Handlooms & Textiles and Apparel Export Parks, Telangana State, Hyderabad and in pursuance of the Budget Release Order issued by the Finance (Exp. I&C) Department in the reference 1st read above, hereby accord administrative sanction for an amount of **Rs.60.77 lakhs** (Rupees Sixty Lakhs and Seventy Seven Thousand Only), instead of **Rs. 87.85 lakhs**, under the Head “2851-00-103-11-11-310-312” i.e., Financial Assistance to Weavers from the B.E. Provision for 2014-15 for the months of June, July and August, 2014, towards balance revenue deficit expenditure payable to NIFT., Hyderabad.

4. The expenditure sanctioned in para (3) above, shall be debited to the following Head of Account.
